853. APOLOGIES FOR ABSENCE

There were no apologies for absence.

854. TO RECEIVE DECLARATIONS OF INTEREST

No members declared an interest in matters on the agenda.

855. TO CONSIDER REQUEST FOR DISPENSATIONS

856. CONFIRMATION OF AMENITIES COMMITTEE MINUTES

The Committee received and approved the signing of the minutes of the meeting held on 12th January 2021 as a true record.

857. PUBLIC QUESTION TIME

There were no members of the public present.

858. TO CONFIRM THE LICENCE TERMS FOR THE SALE OF ICE-CREAM ON THE COUNCIL'S LANDS – ATTACHED

Subject to the following amendments, the Committee confirmed the licence terms for the sale of ice-cream on the Council's lands: -

Page 1 – show precise location for unit siting on plans.

Para 2.94 – amend to allow site access for additional vehicle carrying further stock.

Para 2.73 – amend to clarify that this refers to refuse generated by the operator and not wrappings from the products subsequently discarded by customers.

Para 2.13.4 – delete “produce to the Licensor the policy or policies” and substitute “produce to the Licensor a certificate showing insured values “

Para 2.18.1 – add “Before any Court action both parties will have attended mediation to resolve the issues”.

Para 2.14.1.1 – delete entirely.

Para 2.13 – renumber as some paragraphs have been removed.

Permitted items – only list permitted items and delete all other references.

859. TO NOTE AND AGREE THE LOCATIONS FOR HEDGEROW PLANTING IN ELMHURST PARK AND FEN MEADOW

The Committee noted and agreed the location for hedgerow planting in Fen Meadow, including the preparation of parts of the line of the hedge.

The Committee agreed that Full Council determine the location of the previously agreed hedge planting in Elmhurst Park.

860. TO DISCUSS AND AGREE THIS COMMITTEE’S QUESTIONS IT WISHES TO PUT TO THE PEOPLE OF WOODBRIDGE
