CHAIRMAN'S REPORT

There was nothing to report.

58. **TO REVIEW MODEL STANDING ORDERS 2019**

Councillor Holdcroft talked through the rationale of combining the Highways Committee and the Joint Highways Committee into a Highways Advisory Committee to be attended by Town and County councillors, District councillors when required and Town, District and County officers. He explained that by combining these two committees it would save time and work for councillors and officers.

The Vice Chairman was unhappy to accept the Standing Orders for 2019 as there were new paragraphs at Section 22, Relations with the Press/Media.

The Vice Chairman was unhappy to accept the Terms of Reference for 2019 as they referred to the Highways Advisory Committee.

The Vice Chairman proposed creating a new committee – the Climate Emergency Committee.

It was to be **recommended** to the Town Council to constitute a new committee – the Climate Emergency Committee.

Terms of Reference for the Climate Emergency Committee were to be developed by the Standing Orders Sub Committee. Terms of Reference for the Standing Orders Sub Committee could not be found; these were to be developed by the Standing Orders Sun Committee. Terms of reference for the Highways Committee were to be developed by the Standing Orders Sub Committee.

Councillor Jewers arrived; Councillor Wilks left.

It was agreed to separate the Standing Orders and Terms of Reference into two documents. The Vice Chair asked for the source document for the Standing Orders.
