



1 Respective responsibilities of the body and the auditor

Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

We are unable to complete our review work on the AGAR and supporting documentation as a result of challenge correspondence received. A final report detailing any qualifications and 'other' matters will be provided with the certificate of completion, following finalisation of the review work and any additional work required in relation to this correspondence.

Final External Auditor Report and Certificate 2017/18 in respect of Woodbridge Town Council SF0420

Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with Proper Practices which:

- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report 2017/18

On 24 September 2018, we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2018. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- Section 1, Assertion 1 has been incorrectly completed. In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to significant weaknesses in relation to budgetary controls, as the authority did not regularly review expenditure and variances from the budget. The authority has answered 'Yes' to Section 1, Assertion 1, which, on the basis of the above, is not correct. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
- Section 1, Assertion 2 has been incorrectly completed. In the completion of their detailed report, the internal auditor has drawn attention to significant weaknesses in relation to internal controls, as the authority did not conduct a review of the effectiveness of the system of internal control in the financial year. The authority has answered 'Yes' to Section 1, Assertion 2, which, on the basis of the above, is not correct. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
- Section 1, Assertion 3 has been incorrectly completed. The smaller authority must ensure compliance with all its financial regulations, including the retention of financial and non-financial information in support of financial transactions.

Other matters not affecting our opinion which we draw to the attention of the authority:

- In the completion of their detailed report, the internal auditor has made a number of recommendations in relation to financial regulations, standing orders and payment controls, budgetary controls, income controls and internal controls. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
- We note that the smaller authority did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as it failed to make proper provision during the year 2018/19 for the exercise of public rights, since the notice regarding the period for the exercise of public rights was not published before the start of the period. As a result, the smaller
