<u>Item 227</u>

To consider the East Suffolk Council consultation on revised a Statement of Licensing Policy.

The Licensing Act 2003 requires a Licensing Authority to publish and to periodically review its adopted Statement of Licensing Policy. The 6th edition is due to be published in January 2024. In revising this policy, consideration has been given to the latest guidance issued under the Act and any amendments made to the Act itself. The policy also provides practical clarity to existing and potential licence holders and assists council officers to correctly apply the legal provisions of the Licensing Act 2003.

The Policy sets out how the Licensing Authority will deal with, and make decisions on, licence applications made under the Licensing Act 2003.

There is one addition to the policy: Ancillary Delivery of Alcohol and/or Late Night Refreshment.

The consultation period will close on 28 August 2023. Following the formal consultation process, an analysis of the responses received will be undertaken and the results collated for the Licensing Committee to consider.
