<u>Item 180</u>

To receive an update following attendance by the Town Clerk and Chair at the Planning Forum for Town and Parish Councils.

The Chair and Town Clerk attended the East Suffolk Council organised Planning Forum for Town and Parish Councils, which was held at High Lodge, Darsham on Friday 7th July.

The slides from the presentation have been requested from the Planning Authority and will be uploaded separately to SharePoint if/ when they are received. The notes were taken by the Town Clerk:

- Cllr Yule announced during her introductory speech that the 'Call in' process has been recommended for re-implementation, and she hopes it will be 'in play' by early 2024. For an application to be called in a recommendation of refusal will be required from the relevant Town/ Parish Council and Ward Member, along with significant reasoning based on planning law and policies.
- There has been a low participation from Town Councils at the Referral Panel less than 30% it was later requested by an attendee that Town and Parish Councils are given more notice of an application being taken to the panel in order that representation can be organised through the relevant Council Committees.
- The Planning Authority will soon be consulting on the validation process, which at the
 moment many people have concerns about the lack of detail and order in validating
 applications received Town and Parish Councils feel they are being used as a 'free
 check', as it regularly such consultees who inform the authority of missing documents.
 The Planning Authority accepts that at the current time they cannot adequately
 scrutinise the required level of detail of application at the first stage.
- CIL funding and payments ESC encourage bids of up to £50,000 for match funding toward qualifying projects. ESC Officers also encouraged attendees to use the 'Developer Contributions Database', which is a live database of CIL applications received from developers and payments scheduled to be made to Councils. 
