The Committee provided the following response to application <u>DC/24/0085/TPO - Little</u> <u>Grange 3 Pytches Road Woodbridge.</u>

It was agreed to submit a holding objection subject to the receipt of a full arboricultural report relevant to this application WTC cannot support the removal of trees in the conservation area without supporting professional opinion on the condition of the trees, and details of planned replacement planning.

As requested at the meeting, the Town Clerk communicated this decision to the East Suffolk Council Tree Officer:

Dear Falcon,

The Planning Committee of Woodbridge Town Council considered application DC/24/0085/TPO - Little Grange 3 Pytches Road at their meeting last week and agreed the following:

DC/24/0085/TPO - Little Grange 3 Pytches Road Woodbridge Suffolk IP12 1EP

It was agreed to submit a holding objection subject to the receipt of a full arboricultural report relevant to this application – WTC cannot support the removal of trees in the conservation area without supporting professional opinion on the condition of the trees, and details of planned replacement planning.

This application seeks the removal of two trees and a group of trees with a TPO but provides scant information to allow for a qualified decision to be made. Further to the decision of the Committee, I have been asked to communicate the following:

- This application should not be considered (even validated) until a professional report is provided there is no detail in the application regarding the condition of the trees and the hand drawn map is laughable.
- We respectfully request that you ask for the applicant provide an arboricultural report and inform WTC when this is available for consideration.

Good morning Greg,

Thank you for your comments in regards to the TPO application at 3 Pytches Road. I have assessed the application and considered the Town Council's comments, please see the summary below.

I have confirmed that T2, T3 and T4 are all dead and do not require consent to be felled (exemption works). No replacement planting is required in the regulations for dead trees as they are in a Woodland Order. I have since requested and had confirmation from the agent that T2, T3 and T4 are removed from the application description.

This leaves the Sweet chestnut which is only to be reduced, hence the Town Council's comments relating to replacement planting no longer being applicable. The agent has ticked no to the section of the form which would trigger the need for evidence/professional report if ticked yes:

Please indicate whether the reasons for carrying out the proposed works include any of the following.

I have viewed the tree and it is a large multi stem specimen with significant upper crown die back. Approximately the top 4-5 metres of the crown consists of deadwood (pruning deadwood is exempt from the need for consent). The proposed reduction to remove an additional 5-6 metres of the upper crown is intended to cut back to better quality wood i.e. remove the transitional partially decayed wood. This is in line with good arboricultural practice and is required to both address an existing elevated risk of failure and will also promote the remaining longevity of the tree. I am satisfied that the applicant has submitted the minimum level of required information and permission will be granted on the grounds of good tree management and the existing health and safety risk.
